



Lesson Policy

All lessons are 30 minute private instruction, tailored to the needs of the individual student.

\$10.00 non-refundable registration fee for new students

We have 4 convenient plans to suit your needs:

- **Floating** - payment made at time of scheduling \$30.00 per lesson
- **Monthly** - payment due on the last week of the preceding month \$100.00-\$125.00 / \$25.00 per lesson
- **Quarterly** - payment due on the last week of the preceding quarter \$276.00 / \$23.00 per lesson
- **Family Plan** - for those with two or more students enrolled \$92.00-\$115.00 monthly / \$23.00 per lesson
\$252.00 quarterly / \$21.00 per lesson
\$2.00 off per lesson - individuals taking multiple lessons also qualify

Four Personal Days are included with each plan per year - with at least 6 hours notice, use these for planned absences. For example, personal days can be used over the summer to assist in retaining a preferred lesson time during long absences.

Payment for all lesson plans will be allocated to the teacher at the scheduled lesson time. Lessons may be rescheduled with appropriate notice pending teacher/student availability within 30 days; however, if the store is not notified of a need to reschedule by 2pm Mon-Fri / 9am Sat, the teacher will be paid and the lesson recorded as a *Cancel Late* or *No Show* - **these lessons may not be rescheduled.**

All rescheduling must occur between guardians and lesson administration - teachers are not responsible for their scheduling.

Be prepared to pay at your scheduled lesson time - cash, credit card or personal check *made out to Blackstone Valley Music*

If a lesson is cancelled by a teacher, the facility closing due to weather, or holidays, you will not be charged for the lesson.

Blackstone Valley Music holidays are: New Year's Day, Memorial Day, the 4th of July, Labor Day, Thanksgiving, Christmas Eve Day and Christmas Day, New Year's Eve Day - these holidays will be accounted for in all lesson plans

Times slots will not be held for absences longer than that allowed through the use of Personal Days and proper rescheduling.

One week advance notice is required for early termination of lessons. Penalties for early termination of lesson contract are as follows:

Monthly - lessons used will be charged the floating rate of \$30.00 per lesson and the remainder reimbursed.

Quarterly - \$10.00 fee, plus lessons used will be charged the floating rate of \$30.00 if less than 5 lessons used, if 5 or more lessons were used you will be charged the monthly rate of \$25.00 per lesson, and the remainder reimbursed.
